Publication of the Slaugham Neighbourhood Development Plan

Regulation 16 – The Neighbourhood Planning (General) Regulations 2012 and the Localism Act 2011.

Slaugham Parish Council has submitted its Neighbourhood Development Plan (NDP) for independent Examination.

Slaugham is a large rural parish in the northern part of Mid Sussex with four distinctive villages of Handcross, Pease Pottage, Warninglid and Slaugham. The NDP allocates one site for 30 dwellings at St Martin Close (East) and a reserve site for 35 dwellings at St Martin Close (West) in Handcross. The NDP also includes polices on protecting the environment, sustainability, heritage, open space, infrastructure, community facilities and the economy. Once adopted, these polices will be used to determine planning applications locally along with the Mid Sussex District Plan.

Consultation on the Submission (Regulation 16) version of the Neighbourhood Plan is taking place **from 9:00am Monday 19th November 2018 until Midnight Monday 14th January 2019.** All representations received from this consultation will be forwarded to an independent Examiner appointed to examine the Neighbourhood Plan.
