Site Allocation Development Plan Documents - Following hearing sessions held in June 2021 and the completion of Action Points, the Inspector has provided suggested modifications to the Council's Site Allocations Development Plan Document (Sites DPD), which were subject to consultation from November 2021 to January 2022. At this stage the Inspector has only issued the Main Modifications and not a Report setting out his conclusions.

The Council received almost 300 responses to the consultation. The responses have been collated and made available to view on the Sites DPD examination page. The responses have also been sent to the Inspector to inform his final report. Should the Inspector conclude that the Sites DPD meets legal and soundness requirements, it will be considered by the Council for adoption in Spring 2022.

Mid Sussex District Plan - The Scrutiny Committee for Housing, Planning & Economic Growth, at its meeting on 19th January, agreed to pause consideration of the draft District Plan review.

The Council is mandated by national policy and by the Planning Inspector who examined the current District Plan to undertake a five year review which is now due. The results of this review have now been published so the community can understand the scale of the challenge we face in Mid Sussex.

It is now sensible to press the pause button given the significant issues which impact the Council's planning. Cllr Johnathan Ash Edwards is writing to the Secretary of State, Michael Gove, calling for the housing targets to be reset to a level more consistent with our environmental and infrastructure constraints. The Levelling Up White Paper will be published shortly, and MSDC hope the Government uses this as an opportunity to review the housing numbers currently set for parts of the South East. An updated timetable for the preparation of the Plan review will be published in due course.

The National Planning Policy Framework (NPPF), Relevant paragraphs for AONBs

Paragraphs 176 and 177 of the NPPF specifically relate to National Parks and AONBs.

Paragraph 176: Great weight should be given to conserving and enhancing landscape and scenic beauty in National Parks, the Broads and Areas of Outstanding Natural Beauty, which have the highest status of protection in relation to these issues. The conservation and enhancement of wildlife and cultural heritage are also important considerations in these areas, and should be given great weight in National Parks and the Broads. The scale and extent of development within all these designated areas should be limited, while development within their setting should be sensitively located and designed to avoid or minimise adverse impacts on the designated areas.

Paragraph 177: When considering applications for development within National Parks, the Broads and Areas of Outstanding Natural Beauty, permission should be refused for major development⁶⁰ other than in exceptional circumstances, and where it can be demonstrated that the development is in the public interest. Consideration of such applications should include an assessment of:

- a) the need for the development, including in terms of any national considerations, and the impact of permitting it, or refusing it, upon the local economy;
- b) the cost of, and scope for, developing outside the designated area, or meeting the need for it in some other way; and
- c) any detrimental effect on the environment, the landscape and recreational opportunities, and the extent to which that could be moderated.

The footnote (60) to this paragraph advises that whether a proposal is major development is matter for the relevant decision taker, taking into account its nature, scale and setting and whether it could have a significant adverse impact on the conservation or enhancement of the AONB.

In addition to this the East and West site have agreements that overlap each and in order to maximise value, delivery commitments etc for both sites the Council are working with the adjacent site to resolve these nuances with the assistance of our appointed agent and solicitor.
- 6.3.2. Planning DM/21/3959 | Change of use and conversion of estate buildings from Residential to D2 (Assembly and leisure) and A3 (Restaurants and cafes). Lydhurst Estate Warninglid Lane Warninglid Haywards Heath West Sussex RH17 5TG
 - It is the Committees view that the "change of use" from residential to assembly and leisure to include a restaurant with 80 covers alongside a cookery school, wellness centre and treatment area; yoga studio gym, craft centre, children's area, offices, staff facilities and additional guest accommodation is a significant leap from the current use will have detrimental transport impacts on a designated Conservation Area. The current and what appears to be the continual access to the estate will be via The Street which is entrenched with 16th century buildings that has significant architectural and historic interest. It is with regret that the Council cannot support the application in its current form and asked that the LPA with Highways look at the access and the implications on the village. The Council recognising that whilst progress can be a force for good, it must not be to the detriment of the village, its residents, and the surrounding area.
