**RESOLVED** - The Committee reviewed the 2025/26 Income and Expenditure position, reserves, and supporting reports (Refs 6.1–6.5). The Clerk presented the Financial Monitoring Briefing Note -22 January 2026, confirming a net income over expenditure of **£47,194** (as at 11 January 2026) against a budgeted net deficit of **£30,057**, giving a positive variance of **£77,251**. Income totals **£172,180** (100.6% of budget) and expenditure **£124,986** (62.1% of budget). Members noted that the overall financial position remains strong, with most cost centres tracking well within budget.
7. Report Expenditure Differences – The committee is asked to consider variances since previous review (attached) Members reviewed the expenditure variances since the previous report, noting key movements in parish assets, insurance and energy costs, and confirmed the variances were understood and monitored. **NOTED**
