HISTORIC ENGLAND(formerly English heritage)	Thank you for consulting English Heritage on the Sustainability Appraisal Scoping Report for Slaugham Neighbourhood Plan. The appraisal provides a suitable overview of the designated built, archaeological and landscape heritage assets of the plan area from which to assess the potential impacts of policy and proposal options for the neighbourhood plan. Indeed the brief review of the character and designated heritage assets of each settlement stands out as good practice in presenting evidence of the historic environment within a plan area.	
	However, it would also be helpful to consider the potential for the area to contain non-designated heritage assets (as defined within the National Planning Policy Framework and policies within the Mid-Sussex local plan), for example Buildings of Merit and sites of local and regional archaeological interest, as well as the potential for previously unidentified assets to be present. In the absence of a 'local list' the summary should set out the types of features in these areas that are likely to be considered as heritage assets. For example, the Anglo-Saxon village of Warninglid is likely to be a focus of archaeological remains of early medieval and later occupation that are likely to be of, at least, local interest, including evidence of the regionally distinctive Wealden iron working industry's development. A rapid review of archaeological sites and findspots recorded on the Sussex Historic Environment Record within the plan area would be an important step in ensuring the overview accurately represents the historic environment of the plan area and could be used to provide a very brief overview of types and disposition of previously recorded archaeological remains in the plan area.	Agreed - some further detail will be added to Sustainability Appraisal.
	Whilst the settlements are likely to be a focus of consideration for allocation of sites and provision of new facilities, the overview should also consider the presence of heritage assets within the countryside areas of the parish. Including different areas of historic character. This might be presented graphically using the Sussex Historic Landscape Characterisation to review the distribution of different historic landscape types, identify any that are considered as of particular value (e.g. due to rarity or contribution to the character of the AONB, including historic woodlands), as well as present settlement boundaries.	Agreed-some further detail will be added to Sustainability Appraisal.

	Whilst heritage is often seen as a resource to be protected to pass this onto future generations, it is also a positive resource that is used by our communities in many ways. It would be helpful to consider the present value of the area's heritage to the local economy and communities, including identifying any historic buildings that serve as assets of community value as well as considering where heritage, including access to the countryside and heritage attractions adds to the economy. As an example it would be interesting to consider how the presence of a National Trust property attracts tourists who use local businesses or how an attractive historic evnvironment adds to the attraction of thvillage centres. This can then help with consideration of how the plan might promote greater use of heritage assets, including improving physical and intellectual access, developing opportunities for communities to contribute to management or identifying ways in which heritage assets can provide opportunities for local businesses. This might present some further ways in which changes to heritage can be measured and monitored.	Noted.
